Items that are brought up by the public but which are not posted for discussion or action may not be discussed among the Board members or acted upon by the Board, except for limited questions related directly to the topic or a discussion whether to post the public raised item on a future*

*agenda. The Hearing may limit the amount of time for public comment and/or allow additional public comment for each item. Normally, there is a five minute time limit for each person who wants to offer open comment, testimony or an objection; however, if there are numerous individuals who wish to offer comment on the same issue, the Hearing Officer may ask that the individuals select a representative to speak on their behalf in order to permit an orderly and efficient public hearing to proceed. Individuals or organizations may offer comment, testimony or make objections via a written form available on the DMD's web site, or via letter directed to the DMD. The comment forms will also be available at the public hearing.*
