
Bicycle parking is an important element to Downtown El Paso's transportation system. Providing access to Bicycle Racks near employment, retail, and other destinations ensures parking options for bicyclists. Adequate bicycle parking is good for business, increases ridership, offers an alternative to driving, decreases the demand for automobile parking, and prevents damage to infrastructure caused by makeshift bicycle parking. In addition, supporting active transportation, such as cycling and walking, promotes healthy lifestyles and improved air quality in our community.

This Downtown Management District (DMD) program provides for the installation of standard inverted U-shape bicycle racks on the public right-of-way. Business and property owners can submit a request at any time. Requests will be granted based on funding availability, compliance with City requirements for bicycle racks, and appropriateness for the area.

\*\* Requests made by someone other than the property owner require the notarized signature of the property Owner of Record representing approved authorization and consent for installation.


### Requirements for Bicycle Rack Installation

a. A minimum setback of three (3) feet shall be required between the bicycle rack and the building face or other streetscape elements, such as but not limited to parking meters, trees, street furniture, fire hydrants, and utility vaults. (Figure 1)




b. A minimum setback of five (5) feet shall be required between the bicycle rack and a curb cut or accessibility ramp.

c. For bicycle racks oriented perpendicularly or diagonally to a sidewalk or walkway: a minimum setback of three (3) feet shall be required between the rack and the face of the curb; a minimum of three (3) feet shall be required between each bicycle rack; and a minimum width of eight (8) feet shall remain unobstructed from the pedestrian path of travel when a bicycle is not attached to the rack. d. For bicycle racks oriented parallel to a sidewalk or walkway: a minimum setback of three (3) feet shall be required between the bicycle rack and the face of the curb; a minimum setback of six (6) feet shall be required between each bicycle rack; and a minimum width of six (6) feet shall remain unobstructed from the pedestrian path of travel when a bicycle is not attached to the bicycle rack. e. Wherever possible, bicycle racks shall be located in the parkway, aligned to not interfere with parked car doors or bus stops, and aligned parallel to the street in constrained areas.

### **STEP 4** – Bicycle Rack(s) Installation

Upon approval of the request, the DMD will install the bicycle rack(s) within approximately 45 days from the approval.
