Gudenrath updated the board on how the current COVID-19 pandemic is impacting the DMD administration, sanitation operations, budget and marketing. In terms of operations, crews continue to work 7 days a week and the DMD has worked with the City to identify parking spaces for Food Pick-up and Delivery. In terms of finance, the DMD has laid off Analissa Carreon. This action was mutually beneficial at this time and her rehiring is anticipated upon reopening of the office. In addition, Gudenrath continues to review all expenditures and is requesting relief from all vendors. Gudenrath also reviewed the impact on revenues, and areas where expenditures could be reallocated or eliminated.

Gudenrath stated that events are the primary source for visits to Downtown El Paso, and outlined a Public Event Incentive Program he is proposing to help bring events Downtown once conditions are suitable for public gatherings.
