# 1. Call to order

Mike McQueen called the meeting to order at 11:59 am on December 5, 2019 at United Bank, 401 E. Main Drive, 1<sup>st</sup> Floor Conference Room, El Paso, Texas. Notice of the DMD Public Hearing and Special Board Meeting Agenda was posted at the El Paso County Courthouse, El Paso City Hall, and at the administrative office of the El Paso Downtown Management District, and on the downtownelpaso.com webpage by Teresa Mais on November 26, 2019 in accordance with the Texas Open Meeting Act on the dates indicated.

# 2. Introduction of Downtown Management District Board Members, DMD Staff and Special Guests.

McQueen gave a brief introduction of the DMD Board members, DMD staff and special guests.

# 3. Opening of the Public Hearing regarding Petition Requesting Annexation of New Properties Into the El Paso Downtown Management District

a. Explanation of Public Comment Process

Joe Gudenrath gave an explanation of the public comment process. He stated that individuals addressing the Board sign up to speak and after the staff has conducted the presentation, the Board will invite those who signed up to speak one at a time. He further explained that each speaker should state their name for the record and will be given three minutes. This is in accordance with the DMD's Public Comment Policy. He stated that Board members should hold their comments until the conclusion of comments.

## 4. Presentation by the Downtown Management District

a. Petition Process and Presentation of Petitions Received

Gudenrath gave a presentation on the DMD Boundary Expansion Petition including the background, the requirements for consideration, and details about the proposed area of expansion. In addition, he presented the 13 petitions received in favor of expansion representing 37.46% of assessed value of the expansion area. He stated that four properties opposed.

b. Staff Presentation and Recommendation

Gudenrath stated that due to a lack of support at this time, the Board can either take no action or table the item with the intent to revisit in the future.

## 5. Open Comment\*

- a. Receipt of any informal or formal comments, questions, objections to the Petition Requesting Annexation of New Properties Into the El Paso Downtown Management District Scott Walker stated that he was one of the property owners in the expansion area and he believes that this area is a part of Downtown El Paso. He stated that he would like for a six-month extension to happen in order to get more signatures. He stated that he would like to have private meetings with people who are on-the-fence about what the DMD does.
- b. Receipt of any testimony, proof, or objections to be offered regarding the Petition Requesting Annexation of New Properties Into the El Paso Downtown Management District

  Gudenrath presented the notices of oppositions representing four properties including 315 Missouri Ave (owned by El Paso Scottish Rite Historical), 301 Missouri Ave (owned by El Paso Scottish Rite Historical), an unaddressed partial building on Missouri Ave (owned by El Paso Scottish Rite Historical), and 617 Franklin Ave owned by Franklin Ave Apartments, LLC. Gudenrath read the opposition by Renard Johnson of Franklin Ave Apartments, LLC.

# 6. Action by the Downtown Management District Board of Directors to Table the proposed boundary expansion for six months and to direct staff to work with the Petitioners to seek additional support.

**Discussion:** Sam Legate stated that the area of expansion seems like a logical fit for

Downtown. Jon Law stated that there should be some evaluation of the impact the expansion before determining if DMD should get involved. Pearson stated that he was unsure if the DMD should lead these types of efforts or if it is best

for property owners to manage.
