 The DMD submitted a grant application for a \$500,000 assessment grant at the deadline on December 1, 2021.
 Awards will be announced in May/June of 2022.
- d. Downtown Landscaping and Tree Maintenance The City has not presented the Interlocal Amendment to the City Council and it is unclear when that may occur.
