7. Committee Report: Grant Programs Update

a. Grant Programs Status/Fund Balance Report

Joe Gudenrath gave an overview of the status of existing grant projects and reported the Grant Programs' fund balances. He informed the Board that due to a lack of applications for grants there was no committee meeting in February. Currently, there are seven projects in various stages of progress. There have been zero applications approved this fiscal year. There is a balance of \$268,000 available in grant funding. Gudenrath stated that the committee will meet in March to discuss how to solicit grant applications.

8. Committee Report: Infrastructure & Advocacy Committee

a. Bike Rack Program

Mike McQueen informed the board that the DMD will be installing two bike racks by the Cortez Building on the Mills Street side. He expressed that once these bike racks are installed he hopes others will apply for the program.

b. Paseo de las Luces Project Outreach

McQueen informed the board that Gudenrath and Frank Hernandez met with the project manager for the City of El Paso and that they have not signed the contracts yet, but once it is signed they will collaborate with the DMD to coordinate outreach about the project. He stated that one of the things the DMD will talk to the City about is potentially doing something about parking for the business owners near the Paseo de las Luces because parking will be affected.

9. Committee Report: Marketing Committee

Law informed the Board that Edie Zuvanich is the new Chair for the Marketing Committee.

a. Current & Upcoming DTEP Promotions

Zuvanich stated that January was a very strong month for marketing. She informed the Board that the Downtown Barstool Open exceeded expectations and that the DMD made about \$4,000 in revenue from the event. The event expected 370 participants, but about 400 participants joined. Zuvanich stated that the next Barstool Open is set for January 29, 2019. She gave a brief overview of the Hidden Hearts promotion. She stated that the promotion had about 40 participants and sharing on social media increased this year. Gudenrath informed the Board about the 2nd Annual Downtown Living Tour on Saturday, April 7. Law thanked the DMD staff for their work on the Downtown Barstool Open.

b. Social Media & INSIDER Distribution List

Zuvanich updated the Board about the growth in social media and stated that there has been a consistent increase in followers across all platforms. Monty Rogers expressed that uploading pictures of each team to Facebook from the Downtown Barstool Open was a good idea.

c. DMD in the News

Zuvanich gave a brief overview about what, when, and where the DMD was mentioned in the news in the month of January. She stated that this month was a strong month in terms of media mentions.

10. President's Report

a. IDA Value of U.S. Downtowns and Center Cities Report

Law informed the Board that the DMD received an invitation from the International Downtown Association to participate in a project where they identify the value of U.S. Downtowns. He stated that the Executive Committee discussed the invitation and it was not unanimous in absolute support, but the committee believed it was an opportunity worth discussing. Law stated that he supports this project. Gudenrath further informed the Board about what the project is and the deliverables. He also stated the benefits of doing the study. Gudenrath stated that the cost would not cause the DMD to cut into any existing services. Law stated that the Executive Committee thought the cost was reasonable and one of their concerns was if there could be any negative consequences if the results were not favorable. He stated that another concern was how the study could generate actionable items.

Discussion:

McQueen expressed concern that the study seemed to have a grading process that evaluated what stage Downtowns were at and Downtown El Paso was early in the process of revitalization. Gudenrath stated that IDA is updating the previous participants and it would be easier to update the DMD's data going forward. He stated that the study would be accessible as a public document and the DMD would proactively promote it in the context of recent advancements. Lina Ortega expressed that she thinks doing the study is a good idea to see what is lacking and what needs to be done. Steve Ortega stated that efforts the DMD can use to justify things like code

enforcement from an honest third-party are a good thing. Zuvanich stated that if the study is searchable online by companies that might want to come to El Paso, Downtown will be placing themselves in competition and possibly at a disadvantage with other Downtowns. Eric Pearson stated that it is important to be on a list and show a positive trend. He stated that the DMD should be involved in something that is multiyear so the DMD can revisit and look for opportunities. Law stated that IDA's mission is to build Downtown and are not here to hurt the DMD.

He also gave an overview of the grants that the DMD offered and were approved in 2017 and went on to talk about the events in Downtown. He informed the Board that there was an increase in community involvement in 2017.

b. TIRZ No. 5 Update

Gudenrath informed the Board that the TIRZ approved funding for the Paseo de las Luces project. At their next meeting Gudenrath will present projects the DMD identified.

Frank Hernandez gave an overview and updates of upcoming construction, projects and events. He updated the Board about outreach for the community about the Paseo de las Luces project.

Rafael Arellano provided a brief overview about economic development by the City. He informed the Board about building projects that are underway and about the company Fivestars moving to Downtown El Paso. Lauren Baldwin gave a presentation about alleyway activation.

Gudenrath informed the Board about the Last Thursdays Art and Gallery Crawl taking place that evening and informed them about the Aloft Hotel grand opening in March.
