Laura Pople provided an overview of the DMD's current financial position.

7. Presentation, Discussion and Action to Accept the FY2016-2017 Audit Report - Strickler & Prieto, LLP

Cedric Lyerly of Strickler & Prieto, LLP gave a brief overview of the FY2016-2017 audit report. He stated that no material findings were discovered. He added that the DMD has a substantial amount of cash which shows that the organization is healthy, but stated that the goal is to break even since the DMD operates as a governmental organization.

Pople provided a brief overview of the DMD's current investments.

9. El Paso Children's Museum Update – Dr. Paul Kortenaar, Director, with possible discussion of the topic by the Board (no action)

Dr. Kortenaar gave a brief presentation on the El Paso Children's Museum. He spoke about the cost, exhibits, design, infrastructure, business plan, etc. They are expecting to open in the Fall of 2020.

10. Committee Report: Grant Programs Update

a. Grant Programs Status/Fund Balance Report

Peter Spier gave an overview of the status of existing grant projects and reported the Grant Programs' fund balances. Currently, there are seven projects in various stages of progress. Spier stated that four of the projects have an extension request and one project has submitted for reimbursement. He stated that the DMD needs to find more applicants and asked the board to let anyone know who is working on a project about the grant program.

Gaddy encouraged the board to reconsider the restriction of funds for long term projects until the anticipated completion year of the project. Gudenrath stated that the Finance Committee has already discussed the suggestion, and the Grant Committee will discuss it at its next meeting. Any recommendations would then be brought before the board for adoption.

11. Committee Report: Infrastructure & Advocacy Committee

Ambassador/Security Program Update.
Mike McQueen gave a brief update on the DMD's Ambassador and Security program.

b. Bike Rack Program

McQueen informed the board that the DMD has ordered ten bike racks and once they are delivered the DMD will be ready to receive applications. He stated that the DMD will look for a local vendor to order the bike racks from.

12. Committee Report: Marketing Committee

a. Current & Upcoming DTEP Promotions

Joe Gudenrath gave a brief overview of the upcoming and current promotions including The Downtown Barstool Open and Hidden Hearts. Gudenrath informed the Board about registration count and other details about the Barstool Open. He also informed the Board about the details and logistics of the Hidden Hearts promotion.

b. 2018 DTEP Calendar

Gudenrath expressed his appreciation to those on the Board that bought calendars. He informed the Board that the DMD has used the calendars as a promotional and marketing tool. He said the feedback has been outstanding and sales have been good. He stated that calendars are still available for sale.

Gudenrath gave an update of the number of likes, followers and subscribers the DMD has gained within their social media and newsletter.
