Pearson asked about securing buy in from El Paso Street retailers for the Fiesta de las Luces. Gudenrath stated that there has been outreach to businesses as part of the Special Event Permit Process and there has been limited opposition. He is hopeful they participate in the event by keeping their doors open. Morgades emphasized how important events are for attracting people downtown.
