a. Monthly Financial Summary

Carroll gave a brief overview of the DMD's current financial position. Torres asked about the below budget revenue. Gudenrath stated that it is attributed to slower than normal assessment collections, the lack of the Landscaping Program, and the way grants are booked. Gudenrath noted that the lack of the Landscaping Program will impact the budgeted revenue.

Morgades provided information on the reinstatement of the Community Service Program and current staffing levels. Bustamante recognized the part time staff that have supported the DMD's efforts throughout the pandemic.

Discussion:

Torres questioned if the statement should be limited to Border Patrol or include all public safety agencies. Uribarri stated that the committee discussed the topic and believes the statement should be directed solely at Border Patrol because they are the only agency with a track record of concerning behavior along with the lack of adequate policy.

Pearson stated that he would like to see the Union Depot building added to the list. Mesta asked if we knew how much funding was needed for alleys and if we knew which alleys would be addressed. Morgades stated that we are not at that point in the process. Gudenrath stated that the City is currently collecting community feedback and the process will continue until the City Council makes the final decisions. Osborn stated that projects like the Banner Building may require public investment to make such a project possible and to jump start residential development and private investment in other properties.

Gudenrath and Givens presented an overview of the plan and its recommendations.

Discussion:

Mesta asked if the market analysis included unreported housing and commerce within the area. Gudenrath stated that it was not captured. Mesta stated that 501 Campbell Apartments have been fully occupied since opening and asked why others haven't attempted such projects. Gudenrath stated that that dynamic is why the planning effort is important. Pearson stated that is important that the plan focus on opportunities and then allow the market to pressure other property owners to make improvements. He added that he likes that we are not attempting to gentrify or displace people. Gudenrath also stated that the desired investments could improve the conditions for all people who live in the area. Baem added that she has received multiple phone calls asking for information about the Downtown residential market.
