## 6. Committee Report: Finance Committee

a. Monthly Financial Summary

Carroll gave a brief overview of the DMD's current financial position. Torres asked about the organization's cash position and current investment rates. Gudenrath stated that due to collections of assessment revenue, cash on hand is stable. Mais stated that the DMD is receiving a 4.5% interest rate through TexPool.

### 7. Committee Report: Grant Programs Update

Mais gave a brief overview of current projects and budget status.

### 8. Committee Report: Infrastructure & Advocacy Committee

- a. Position Statement Considerations & Updates
  - i. National Historic Registry Designation

Gudenrath stated that the committee was looking to work with the County to support this effort, if the City would amend current code. No Board action is needed to pursue this outcome.

ii. Short Term Rental Ordinance

Morgades stated the committee is supportive of a basic registration requirement and payment of local HOT. Stout said the County is supportive of HOT payment. Gudenrath will follow up with H&LA, EP Chamber, and Destination El Paso. A position will be brought to the Board in April.

iii. Climate Charter

Board members discussed whether or not the DMD should weigh in. If a position is considered, presentations would be made to the Board. The committee will consider a position.

iv. Alcohol Licensing near Churches

Gudenrath stated that no action is currently needed, but staff is reaching out to involved parties and will monitor the ongoing situation.

#### 9. Committee Report: Marketing Committee

a. Current & Upcoming DTEP Promotions

Diaz and Resignato reported on the Downtown Living Tour and Tasting Tour events, along with a Mural Scavenger Hunt promotion.

b. Social Media & INSIDER Distribution List

Diaz reviewed the current levels of engagement across the DMD's social media channels and newsletter.

Gudenrath reviewed DMD media mentions in February 2023.

Bustamante gave a brief update about current construction projects still underway in the downtown and upcoming events.

### 13. Economic Development Update by City of El Paso

Representative Kennedy stated that the City has not abandoned an arena project, and continues to seek site alternatives. Burton asked about the City's role in the Climate Charter issue. Kennedy stated that the City is hosting meetings, cannot take official positions, and will produce a cost impact analysis. Ortega stated that as citizens and without the use of City resources, elected officials should take positions and advocate accordingly. Parra asked for the schedule of public meetings.

### 14. Economic Development Update by El Paso County

Commissioner Stout stated that the Court had a productive meeting on March 20 and is interested in being a productive partner in the redevelopment of the City owned properties in Union Plaza. Ortega expressed his support of the County's interest.
