Canales stated that he is identifying options to improve operations and that he and the DMD have a similar outlook towards this issue. Ortega stated that a reduction in operations would undermine Transit Oriented Development efforts. Mesta stated that the opening of the MACC and La Nube will provide even greater ridership opportunities.
