10. Committee Report: Infrastructure & Advocacy Committee

- a. Position Statement Updates
 - National Historic Registry Designation Morgades stated that the DMD continues to support the program but has received some concerns from property owners. The DMD will continue to support and encourage the County's outreach efforts. Ortega stated that he has concerns with supporting the District as presented, and believes that if the County really wants to support the small property owner, they should develop a program with needed tools and fund to support interested property owners.
 - ii. Short Term Rental Ordinance Morgades stated that the addition of HOT tax on short term rentals is supported by the Chamber and the Hotel & Lodging Association. There is no timeline for City Council consideration.
 - iii. City of El Paso Downtown/Uptown Master Plan
 Morgades stated the plan was presented to the DMD in April and item #12 expresses support.
 Gudenrath identified the main focus of the plan and approval schedule.
- b. Update on local coordination and preparation for migrant surge.

 Morgades, Gudenrath and Bustamante provided information on recent planning and efforts. Pearson provided information on partnerships with NGOs. Ortega asked that the Board consider taking a position on legislation being proposed by Congresswoman Escobar. Legate commented on the media coverage and asked about the impact of perceptions. Gudenrath stated that media coverage will have a lingering impact and the DMD is looking to diminish some of that through marketing efforts. Taylor shared a story of a positive impression had by visitors. Osborn expressed some concern over El Paso's image. Pearson stated that setting the record straight and controlling El Paso's image has always been community need. Mesta asked about the impact on hotels. Morgades stated they experienced some cancelations, but the overall business has been steady.
