 - i. Texas Tech/Union Depot

Gudenrath shared with the Board the analysis completed by the El Paso Community Foundation. Canales reported that Texas Tech leadership were in El Paso to meet with Community Foundation and City officials, but officials were not aware of the plan resulting in some confusion by those involved. Ortega stated that despite whatever happened at the meeting, the idea of expanding Texas Tech within Downtown El Paso should be the long-term vision for the community and a goal worth pursuing.

ii. Multi-Purpose Center

Gudenrath reported that the City of El Paso will be conducting an Request for Information (RFI) process to gain community and developer input. The DMD will provide its input. Ortega stated that recently built arenas have surpassed \$160 million.
