Steve Ortega called the meeting to order at 11:35am on May 23, 2024 in the offices of Emergence Health Network, 201 E. Main, Suite 600, El Paso, Texas. Notice of the DMD Board of Directors Meeting Agenda was posted at the El Paso County Courthouse, El Paso City Hall, and at the administrative office building of the El Paso Downtown Management District, and on the downtownelpaso.com webpage by Teresa Mais on May 17, 2024 in accordance with the Texas Open Meeting Act.

### 5. Buildings of Impact Presentation & Discussion

a. <u>Newberry Building & Krupp Building Presentation by Joel Guzman</u>

### b. Update by Joe Gudenrath

Ortega reported that Guzman could not attend the meeting and there is no report. This item will be placed on the June agenda for presentation.

#### 6. Presentation and Discussion on El Paso County's Multi-Year Capital Plan & Bond Proposals

Cristian Martinez and Jose Landeros from El Paso County updated the Board on the status of the County's Capital Plan, potential bond proposal and next steps. The update was followed by questions and discussion amongst the Board. Ortega asked if supplemental funds for the City's MPC could be included. Landeros stated there are two projects identified that include non-county partners – the MPC and UTEP's Sun Bowl improvements. Both projects did not receive support from the Bond Advisory Committee, but they are still soliciting input on the projects and they could potentially be added. Giner asked what needed to be done for DMD to support MPC project funding. Gudenrath stated that a previous position statement authorized him to offer support and advocate for the funds. Osborn asked if there were any funds identified to support historic preservation. Landeros stated that there are no programs or preservation projects identified. Giner asked about providing input other than attending the meetings. Landeros welcomed input by any form of communication. Gudenrath stated that he will share any upcoming opportunities with the Board.

#### 7. <u>Presentation and discussion about the current status and future needs for El Paso Convention Center</u> <u>business by Jose Garcia, Destination El Paso</u>

Garcia shared information about the current Convention Center and expansion needs to attract convention business to El Paso. The presentation was followed by questions and discussion amongst the Board. Pearson asked if improvements to the Chavez and existing convention center should be considered along with expansion plans. Garcia stated that the required Chavez repairs are significant and the scope of such a project has not been determined. The Convention Center has been well maintained over the years. Giner asked what action needs to be taken. Garcia said conversations at City Hall are occurring, and he will continue sharing this message. Ortega asked if MPC funds can be used for convention center expansion. Garcia said there is a legal opinion that restricts the usage for such a project, but there are differing opinions from others.

### 8. <u>Committee Report: Finance Committee</u>

  - Mais gave a brief overview of the DMD's current financial position.
- b. FY2024-2025 Budget Process & Preliminary Property Valuations Gudenrath gave a brief overview of the upcoming budget process, and the preliminary valuation issued by the CAD in April.

### 9. Committee Report: Economic & Residential Development Committee

a. Grant Programs Status/Fund Balance Report Mesta gave a brief overview of completed projects, current projects and budget status of DMD managed grant programs. Giner asked about promotion of the programs. Gudenrath said they promote projects upon Board approval and do have funds to promote the programs.

### 10. Committee Report: Infrastructure & Advocacy Committee

- a. Brownfields Assessment Grant Project Update
  - Gudenrath updated the Board on the status of a district wide inventory and outreach efforts.
- b. Position Statement Updates and Discussion
  - i. Sociable City Assessment/Noise Ordinance/Outdoor Amplification Permit Gudenrath reported that the Responsible Hospitality Institute presented it's recommendations to City Council. The following day, City staff met with stakeholders to discuss the findings and an implementation strategy. The report recommends amending the Noise Ordinance and Outdoor Amplification Permit. In addition, the City Council unanimously approved an amendment to the Outdoor Amplification Permit Ordinance removing the DMD's exemption. Gudenrath stated he would work with the City and businesses to comply with the new requirements. Osborn asked if specific

recommendations regarding the Noise and Amplification ordinances were provided. Gudenrath stated the consultant advised that El Paso needs to determine its levels and where those levels should be enforced.

 Parking Meter Revenue for Debt Service Gudenrath advised the Board of a recent presentation given by City CFO regarding Parking Meter Revenue being used for payment of debt service. The Board can expect a position statement for consideration at the June meeting.

### 11. Committee Report: Marketing Committee

- Current & Upcoming DTEP Promotions Alemán reported on the recent Downtown Hotel Tour, Business Mixer, and Food Truck Fiesta. In addition, she reported on the upcoming Tasting Tour.
- b. Social Media & INSIDER Distribution List Diaz reviewed the current levels of engagement across the DMD's social media channels and newsletter.
- c. DMD in the News Diaz reviewed DMD media mentions in April 2024.

#### 12. Committee Report: Special Assessment Evaluation Committee

a. Making the Case and Investing in the Future Gudenrath reported outreach continues but an increase in the assessment rate will not be included in the upcoming budget. The committee will meet in the near future.
